

Reporting into the Director of Governance the Data Analyst – Systems and Performance will be responsible for leading the analysis and reporting of internal systems and operational data, supporting strategic decision making, compliance and continuous improvement across the business.

 - Collaborate with the senior team to enhance system functionality and user experience
 - Monitor system adoption and data integrity across platforms
- Operational Performance:
 - o Develop dashboards and reports for internal stakeholders
 - o Data wrangling, summary, presentation, and visualisation for the team
 - o Support strategic planning with data-driven insights
- Governance & Compliance:
 - o Prepare reports for regulatory bodies (e.g., RSH, Homes England)
 - o Monitor data quality and ensure GDPR compliance
 - o Identify and flag compliance risks or anomalies
